Due to overwhelming response and existing enhanced capacity (Phase-I completed in FY 2022-23) sold out completely, the Company has undertaken Phase-II expansion plan for increasing the manufacturing capacity by 600 nos. cascades per annum with a total capital outlay of INR 125 crores appx. Subsequent to this expansion, which will be completed by end of FY 2023-24, total manufacturing capacity will be 1080 nos. cascades per annum. Further, under this Phase-II expansion, Company is also making provision for manufacturing of Hydrogen Cylinders for seed marketing.
