I, Arun Dash, proprietor of M/s. I submit my report as under:

Management's Responsibility

1. The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) MCA Circulars; and (iii) LODR relating to the Postal Ballot and remote e-voting on the resolution proposed in the Notice of Postal Ballot. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

Scrutinizer's Responsibility

2. My responsibility as Scrutinizer is restricted to making a Scrutinizer's Report of the votes cast "in favour" and/or "against" on the resolution contained in the Notice of Postal Ballot, based on the reports generated/data downloaded from the e-voting system provided by Link Intime India Private Limited (Link Intime), the authorized agency engaged by the Company to provide e-voting facility and documents furnished to me electronically by the Company and/ or Link Intime for my verification.




Cut-off date


3. 4. Remote e-voting process

- i. The remote e-voting period remained open from Wednesday, October 30, 2024 (09:00 a.m. IST) to Thursday, November 28, 2024 (5:00 p.m. IST).
- ii. The votes cast were unblocked on Thursday, November 28, 2024 at 05.30 p.m. and was witnessed by two witnesses, Mrs. Monalisa Parida and Mrs. Santoshi Kedare, who are not in the employment of the Company and they have signed below in confirmation of the same.
