Sub: Intimation regarding fire incident in **PART OF THE PREMISES (LEASED)** for manufacturing unit of Packaging product at Jambusar Vadodara (Gujarat)

Ref: Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

We inform you that a fire incident occurred today (early hours Wednesday, 12th February 2025) in the PART OF THE PREMISES located at 105/109 Padra Jambusar Highway, Uchchhad Taluka Jambusar Dist Bharuch (Gujarat) 392 150, which is the ongoing manufacturing facility for Packaging products.

The fire was brought under control quickly by the local Fire Department Authorities and our internal team locally with in-house firefighting systems. No human casualty and injury are reported. As the products manufacture in this unit are also manufactured at our other multiple manufacturing locations in India, the supplies from those units will fill in the gap and we do not anticipate any business loss.

We would like to state that the assets are fully insured, and Company is in compliance of required Rules & Regulations. The Management is in process of ascertaining the loss for submission to the Insurance Company.


